# **Standing Committee Reports**

# **Financial Report**

An explanation was given for the increase in yearly premium for the Executive Secretary bond insurance. A review by the insurance company revealed that our insurance was out of date and too low to cover the outstanding assets. An increase in coverage resulted in an increased premium. On Thursday, January 26, 2017, an 8-hour seminar, <u>Appraising Rural Residential Properties</u> will be offered jointly with the South Dakota ASFMRA Chapter. The instructor will be an approved ASFMRA instructor.

On Friday, there will be two 7-hour seminars offered:

<u>Effective Appraisal Writing</u> – An Appraisal Institute seminar co-sponsored by the WY and Western SD Chapter of the Appraisal Institute. The instructor will be Alan Blankenship, Ph.D., an Appraisal Institute instructor.

<u>Drone Technology & Its Impact on the Appraisal Industry</u> – Lamar Ellis, III, MAI, SRA, will be the instructor. PAASD and the SD Chapter of the ASFMRA will also jointly sponsor this seminar.

There will again be a survey for the Annual Meeting attendees to complete to help the Education Committee plan future education.

# **Special Committee Reports:**

# **Legislative Report**

Craig Steinley reported on the funds in the Legislative Fund. He commented that perhaps there will come a time that the PAASD budget will no longer need the \$1,600 line item for the legislative fund since the fund has reached its target level.

He also noted that Barry Wilfahrt has been retained by the NDAA as their lobbyist. This will enable North Dakota and South Dakota to work together more closely on legislative matters affecting appraisers.

President Adam introduced Sherry Bren, the Executive Director of the SD Appraiser Certification Program, who gave an update for the Program. Ms. Bren said that in reviewing the Appraisal Management Companies regulatory authority requirements, it appears that the current statutes may cover all the requirements. Possible AMC authorities are currently the only possibility on the horizon requiring legislation, and only if the existing statutes are not sufficient.

The Appraisal Certification Program got an "excellent" rating in the recent review done by the Appraisal Subcommittee.

Ms. Bren announced that the rules update includes a Midway to Upgrade Review after 50% of experience has been reached. Those who are on a path to upgrade will be able to submit appraisals and a review will be conducted to let them know if there are any deficiencies in their work product. This will give them the ability to correct the deficiencies prior to their final review. Further remedial education may be suggested, but won't be mandatory. Those who submit appraisals for this Midway to Upgrade Review will not face disciplinary consequences for deficiencies.

The complaint process was also reviewed. All complaints received by the Department will be treated as an Allegation of Non Compliance. If an investigation reveals that it has credibility and the Department finds there are areas of deficiencies that warrant disciplinary action, the Secretary of the Department will file the complaint. Only at that point is the allegation finally labeled a "complaint" by the Department.
