## SUPPLEMENT TO PAASD PROFESSIONAL DEVELOPMENT SCHOLARSHIP APPLICATION

PAASD Professional Development Scholarships were created to assist current PAASD members in the advancement of their professional careers.

### Eligibility and Requirements:

- 1) Applicant must be or become a member of PAASD at the time of application.
- 2) Applicant must, at a minimum, have a SD Registered Trainee Appraiser Credential in good standing with the SD Appraiser Certification Program
- 3) Applicant must submit a completed application
- 4) Applicant must submit a written essay of less than 500 words stating why he or she should be awarded the scholarship, experience in the profession, and professional goals
- 5) Applicant must submit a resumé
- 6) Applicant must submit one letter of recommendation regarding your merits for the scholarship. The letter may be from a current member of PAASD/or appraiser currently practicing in profession in good standing with the state of SD

When preparing your essay to be submitted with your application, please explain and provide details regarding:

- 1) Why you feel it is important to be a member of PAASD
- 2) Your financial need for this scholarship
- 3) Your plan/timeline for achieving your goals including attaining necessary appraisal experience

### Conditions:

- 1) Scholarship money may be used for the following:
  - A. Qualifying Education for upgrading State Credential
  - B. Acquiring a professional appraiser designation SRA, MAI, ARA, etc.
  - C. PAREA – One PAASD Professional Development Scholarship per Module.
  - D. All Qualifying Education courses must include a test that the applicant successfully passes.
- 2) Scholarship money will be paid directly to the applicant upon receipt and verification of course/PAREA attendance and successful completion and receipts for expenses incurred.
- 3) The amount paid to the applicant will be no more than the verified expenses. The maximum amount paid will be no more than the amount of the scholarship awarded. Eligible expenses include cost of course, travel, etc.
- 4) Scholarship money must be used within 18 months of the date it is awarded.
- 5) Eligible recipients may receive only (1) scholarship per year.

All applications will be reviewed and all information verified by the PAASD Scholarship Committee.
